FEES

pre-hearing activity per hour \* \$225.00  
hearing (minimum 1 day of hearing) \$1,600.00  
(travel: pro-rated per diem)

Note: pre-hearing time is charged for administration, pre-hearing conferences, and other pre-hearing activity totaling over an hour.

A per-diem fee is charged for each eight-hour day of travel, hearing, study, and writing. The full per-diem is charged for all hearing days. More than one day's per-diem is charged and pro-rated for hearing or travel extending beyond eight hours on a hearing day. Study and writing for less than a full day are pro-rated.

20 days of the date of hearing. One day plus half of all scheduled days beyond the first if within  
10 days of first days. All scheduled days if within 5 days.
